- To undertake a continual programme of Risk Assessment in relation to your role.
- Attend training as and when required to continue your development in the role and comply with changes within the gas industry.
- Attend Team Briefs, Toolbox Talks and Technical Bulletins on a monthly basis or asand when required.
- Utilise both electronic and paper-based systems to accurately record gas documentation including the use of labour and materials against each job.
- To demonstrate a positive, diverse and inclusive attitude to both internal and external customers and colleagues.
- To mentor apprentices as and when required.
- The post holder may be required to perform duties, appropriate to the post, otherthan those given in the job specification.
- You will be expected to carry out servicing including the issuing of LGSR's, repairs and installations to the highest of standards.
- Liaise with tenants, clients and members of our supply chain
- Maintain van stocks and provide information enabling the improvements of first trefixes for the area you work within.
- Be flexible and willing to work overtime to cover workloads during busy periods.
